The Eastern Board of Supervisors held their monthly meeting on Monday, June 10, 2024. Those present were Supervisors Michael Lage, Jason Moller, Amanda Dobratz, Clerk Sue Ellwanger and Treasurer Dana Guse. Tim Bowman from Bowman G & G was also in attendance

Board Chairman, Michael Lage called the meeting to order at 7:00 pm. The Pledge of Allegiance was recited.

Jason Moller made a motion to approve the agenda with flexibility. Amanda Dobratz seconded the motion. All voted in favor of the motion. The motion was approved.

Clerk Sue Ellwanger read the minutes from the May 2024 Board Meeting. Amanda Dobratz made a motion to approve the minutes with corrections. Jason Moller seconded the motion. All voted in favor of the motion. The motion was approved.

Treasurer Dana Guse gave the financial report.

The checking account balance on May 31, 2024: \$277,625.90. The CD's had a balance of \$153,083.34. On May 31, 2024, the township balance in the bank was \$430,709.24. Jason Moller made a motion to accept the treasurers' report as presented. Amanda Dobratz seconded the motion. All voted in favor of the motion. The motion was approved.

Parkers Prairie Community Ambulance Report

Michael Lage gave the report from the Parkers Prairie Community Ambulance. The entire report is on file with the clerk.

Road Maintenance

Tim Bowman from Bowman G & G gave the monthly road maintenance report. Township Roads were bladed 1time in May. There was an emergency culvert replacement on 120th St. A culvert on the minimum maintenance road was cleaned out. Tim has been in contact with Alden Just, and there is a good possibly that calcium chloride will be applied on the township roads in the next week or so. Pro to that happening, Tim will grade and apply gravel on the roads where needed.

Outdoor Toilet Renovation

Ryan Truax will take on the job of renovating the outdoor toilets. This is a small job and will be worked into his schedule.

June Weed Inspection

The supervisors set Thursday, June 13th to do the first weed inspection. They will meet at the town hall at 5:30 pm.

New Business

2024 Bridge Inspection Report (100th St. over Spruce Creek)

During a county Bridge Inspection, the township received notification of sediment in the culverts (bridge) over Spruce Creek. Following inspections in the past, The DNR has not let the township do any work on the bridge. Mike Lage will contact the DNR hydrologist to see if the township would be able to remove the sediment.

Dirt Bikes riding on the township lawn and township roads

There are ongoing incidents of persons riding dirt bikes and making a mess on both the township hall lawn and on the township roads. The response we have is to contact the sheriff's Department and make them aware of the issues.

Appointment of Election Judges for the August Primary election.

The clerk presented Michael Lage, Amanda Dobratz, Dana Guse, Rita Wehking, Connie Tarasek, Robert Lahman, Carol Larson and Sue Ellwanger as the ballot board for Eastern Township. Jason Moller made a motion to appoint the proposed people as the ballot board for Eastern Township. Amanda Dobratz seconded the motion. All voted in favor of the motion. The motion was approved.

Election Judge Training

The clerk shared the dates for in person election judge training. The dates are Thursday July 11th in Fergus Falls and Wednesday July 17th at Thumper Pond in Ottertail. Election Judge training can also be done on-line.
