Meeting Minutes**

The Eastern Board of Supervisors held their monthly meeting on Monday, May 13, 2024. Those present were Supervisors Michael Lage, Jason Moller, Amanda Dobratz, Clerk Sue Ellwanger and Treasurer Dana Guse.

Board Chairman, Michael Lage called the meeting to order at 7:05 pm. The Pledge of Allegiance was recited.

Jason Moller made a motion to approve the agenda with flexibility. Amanda Dobratz seconded the motion. All voted in favor of the motion. The motion was approved.

Clerk Sue Ellwanger read the minutes from the April 2024 Board Meeting. Jason Moller made a motion to approve the minutes as read. Amanda Dobratz seconded the motion. All voted in favor of the motion. The motion was approved.

Treasurer Dana Guse gave the financial report.

The checking account balance on April 30, 2024: \$ 213,067.88. The CD's had a balance of \$153,083.34. On April 30, 2024, the township balance in the bank was \$366,151.22. Amanda Dobratz made a motion to accept the treasurers' report as presented. Jason Moller seconded the motion. All voted in favor of the motion. The motion was approved.

Parkers Prairie Community Ambulance Report and Medical Trust Meeting

Road Maintenance

Township Roads were bladed 2 times in April. Jason Moller made a motion to purchase 2 loads of crushed asphalt and applied to the County Line Road/645th Avenue. Amanda Dobratz seconded the motion. All voted in favor of the motion. The motion was approved.

Spring Road Inspection

Mike Lage reported on the Spring Road Review. Gravel will be applied to township roads and culvert aprons on 610th and 595th Ave need to be back filled. A culvert on 595th Ave. needs to be replaced and apron installed on the culvert on 110th St. The turn chevron on 115th needs to be reinstalled. The complete document is on file with the clerk.
