

Eastern Township Reorganization Meeting

March 24, 2025

The reorganizational meeting for the Eastern Township Board was held on Monday, March 24, 2025.

The clerk administered the oath of office to Supervisor Joey Rud and Treasurer Dana Guse.

The meeting was called to order at 5:30 p.m. by Chairman Michael Lage. Present were Supervisors Michael Lage, Joey Rud and Jason Moller, Clerk Sue Ellwanger, Dana Guse, Treasurer. The Pledge of Allegiance was recited.

Jason Moller made a motion to adopt the agenda with flexibility. Joey Rud seconded the motion. All voted in favor of the motion. The motion was approved.

Joey Rud nominated Michael Lage for chairman. Jason Moller seconded the nomination. Nominations were closed. Joey Rud made a motion to elect Michael Lage as chairman. Jason Moller seconded the motion. All voted in favor of the motion. The motion was approved.

Joey Rud nominated Jason Moller as Vice Chairman. Michael Lage seconded the nomination. Nominations were closed. Joey Rud made a motion to elect Jason Moller as Vice Chairman. Michael Lage seconded the motion. All voted in favor of the motion. The motion was approved.

Jason Moller made a motion for Michael Lage to be the representative from Eastern Township on the Parkers Prairie Community Ambulance Board. Joey Rud seconded the motion. All voted in favor of the motion. The motion was approved.

Jason Moller made a motion for the Parkers Prairie Independent and the Independent News Herald of Clarissa to publish official and legal announcements for the township. Joey Rud seconded the motion. All voted in favor of the motion. The motion was approved.

A motion was made by Joey Rud for Midwest Bank of Parkers Prairie to be the financial institution for the township. Jason Moller seconded the motion. All voted in favor of the motion. The motion was approved.

A motion was made by Jason Moller to set the salary of the treasurer at \$2,500.00 per year, the clerk \$2,500.00 per year and the salary of the chairman at \$625.00. Joey Rud seconded the motion. All voted in favor of the motion. The motion was approved.

Jason Moller made the following motion:

- Regular meeting: \$100.00
- All day meetings- Hourly Rate of \$25.00 per hour
- The hourly wage shall be \$25.00 an hour
- Mileage will be at the Federal Rate, and will change when the Federal Rate is updated
- Hired labor at \$25.00 per hour.
- Election Judge Wages: \$25.00 per hour
- Moderator for annual meeting: \$100.00

Joey Rud seconded the motion. All voted in favor of the motion. The motion was approved

Joey Rud made a motion to adopt resolution 2025-01:

Whereas Michael Lage, Jason Moller and Joey Rud were elected by the voters as supervisors of Eastern Township.

And whereas, general maintenance in Eastern Township would be a part of the supervisors' duties, Therefore, be it resolved, that Michael Lage, Jason Moller and Joey Rud supervisors of Eastern Township perform general maintenance in Eastern Township, as required, at the rate of \$25.00 per hour and at the Federal rate for milage.

Jason Moller seconded the resolution. All voted to adopt the resolution. The resolution was adopted.

Jason Moller made a motion to hold the monthly township board meetings on the 2nd Monday of the month at 7 pm and to be held at the Township Hall. Joey Rud seconded the motion. All voted in favor of the motion. The motion was approved. The dates of the 20245monthly meeting will be as follows: April 14, May 12, June 9, July 14, Aug. 11, Sept. 8, Oct. 13, Nov. 10 and Dec. 8, 2025. January 12, Feb. 9, March 9 and April 13, 2026.

Jason Moller made a motion to adjourn the meeting. No seconded is needed. The meeting was adjourned at 5:48 p.m.
